# A NOTE FROM MONCHO FERRER

The COVID-19 pandemic put the progress of the past decades at a standstill. It disrupted the economy and the lives of families and communities, especially those in vulnerable situations. It challenged the education of millions of children and widened the already existing gender gap.

However, amidst all this, I am proud to say that we at RDT found the strength, support, solidarity and motivation to keep working. To keep fighting for a better world, more than ever.

My father used to say, "I have faith in people and their capacity for action". This is a statement I grew up listening to and has been close to me, but these words acquired a special significance in the last couple of years.

women's sanghams, set up special groups for single mothers to improve their self-esteem, and supported them to become active and respected agents of change in society.


We improved the public infrastructure of the district and supported lakhs of farmers to access water harvesting facilities, making cultivation of the land a viable option for living.

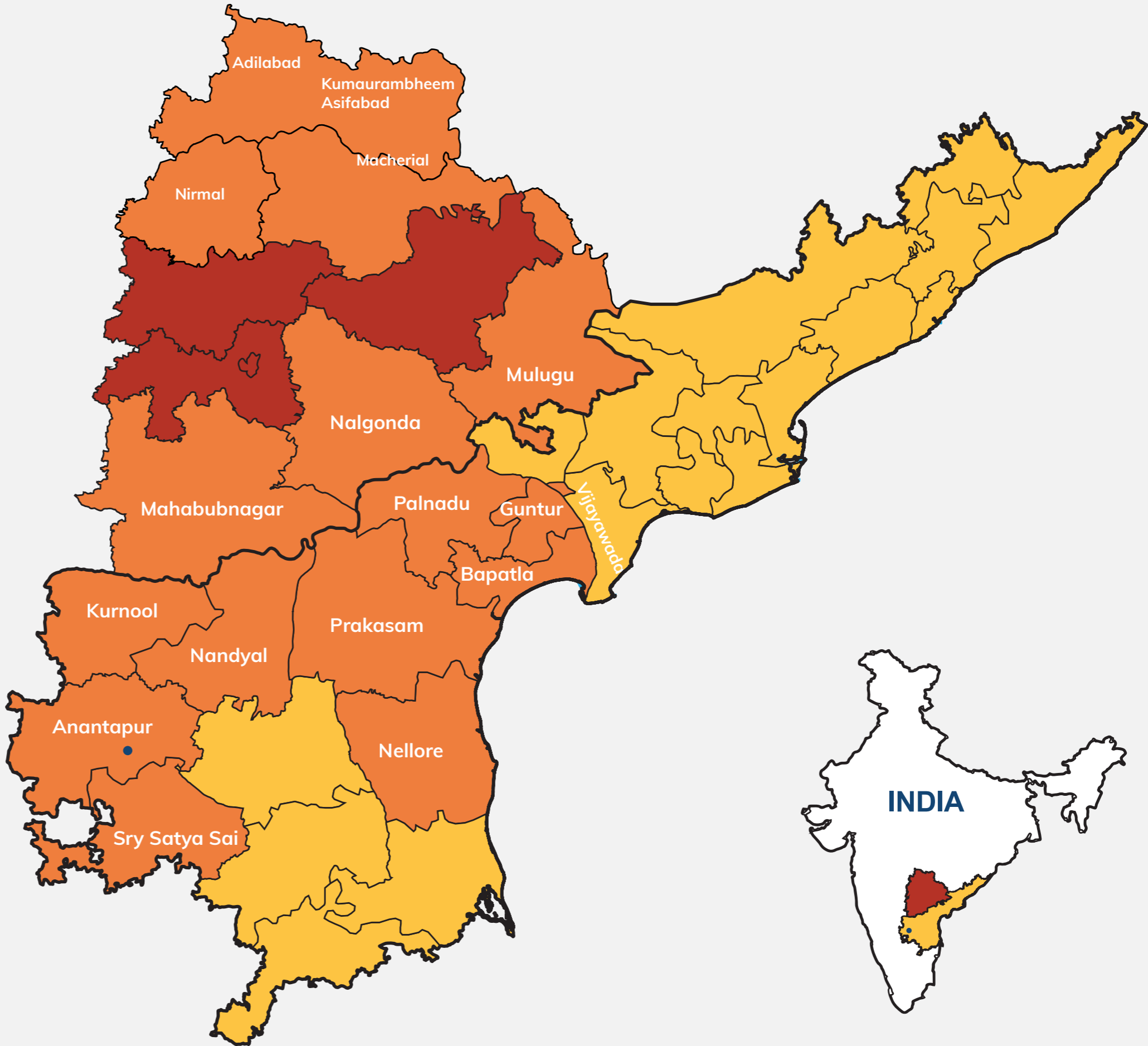

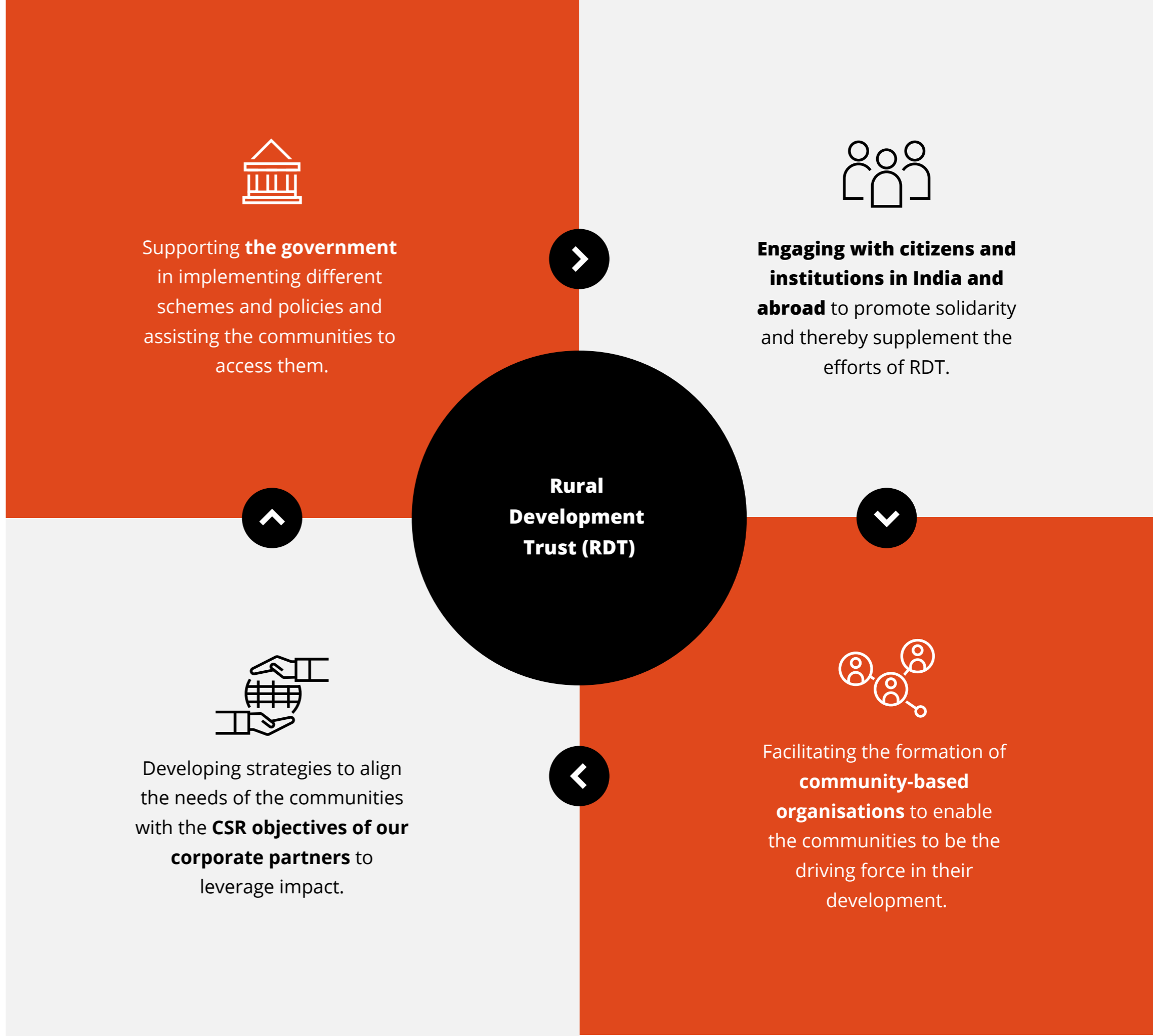

# HIGHLIGHTED EVENTS 2021-2022

**New seeds of change**

**GOAL FOR EQUALITY**

RDT, in collaboration with La Liga Foundation, in 2021, launched the first residential academy for girls in India. Twenty girls under 15 from Anantapur's rural communities were selected to join this programme for the first time. Through this, they receive financial and educational support to reside and train at the Anantapur Sports Village (ASV) facilities.



**TEN YEARS OF WORKING IN SRISAILM**

**Milestones**

**TOGETHER IN THE FIGHT TO END TB**

It has been ten years since the first RDT team started working in the Srisailam forest region to support the local Chenchu tribe and contribute to their development and progress. All these years and until today, the work has been implemented hand in hand with the Integrated Tribal Development Agency and the Forest Department.



RDT Hospital for Infectious Diseases was appointed by the end of 2021 as one of the very few hospitals in India to provide a new short injection-free treatment that could be a game-changer in combating Multi-Drug Resistant tuberculosis (aTB) in the country. This treatment is expected to improve adherence to treatment and, thus, the recovery of patients suffering from drug-resistant tuberculosis.



**MANA BHOOMI, OUR EARTH IS OUR HOME**

In October 2021, we launched Mana Bhoomi, RDT's new initiative to build environmental awareness and responsibility among the people and implement innovative and sustainable projects that benefit the earth.



**Emergency Response**



**RDT'S RESPONSE TO THE ANDHRA FLOODS**

RDT emergency relief teams provided basic provisions and essential items to over 5,000 families in the Chittoor district and over 6,500 families in the Nellore district after the severe floods occurred in Andhra by the end of November. RDT medical team treated over 1,000 persons in less than a week in the areas surrounding Tirupati.

# SECOND WAVE OF COVID-19 IN INDIA

RDT was reappointed as an exclusive COVID-19 centre on 20th April 2021 upon the request of the district authorities. With the capacity to accommodate 300 people, RDT Bathalapalli Hospital came forward once again to support

the local authorities in handling the rapid surge in the number of COVID-19 cases that the country and the district faced during the second wave. In less than 24 hours of reappointment, all the beds were occupied.



A triage area was set up at the entrance of the Hospital to respond to the increasing number of patients.



RDT Kalyadurg Hospital remained open to ensure that pregnant women had a place to go for safe delivery.



**450 medical and non-medical staff worked round the clock to ensure treatment to those in need.**



In order to respond to the increasing number of cases, two new buildings were rehabilitated in the same Bathalapalli Campus.

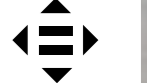

# LINES OF WORK

**To reduce gender-based violence through workshops, counselling services for families and active assessment and protection for those who seek shelter and professional assistance.**

The number of RDT Counselling Centres increased from 6 to 14 over the last one year as a response to the growing number of domestic violence cases and the increase in the number of women who broke the silence surrounding it.

The 6,471 members actively engaged in the Social Active Teams have been essential in tackling gender violence at the village level and stopping early marriages. RDT's Shelter Home, where women and girls in distress are provided with accommodation, food, vocational training/formal education and psychological support, assisted and supported 43 girls and women survivors of gender violence, 50% more than in the previous year.

**To improve the health and well-being of women and girls by facilitating their access to affordable healthcare, through RDT Rural Hospital Network or Government facilities, with special emphasis on reproductive health and anaemia.**

14,902 women were assisted with institutional deliveries at the RDT Rural Hospital network, and 6,346 women's pregnancies were followed up. Out of those, 457 were detected as high-risk pregnancies and received special counselling by the Health Organisers. To tackle the burden of anaemia among women in rural areas, 10,402 women have been screened for anaemia and received treatment and awareness about nutrition and a healthy lifestyle.

**To narrow the gender gap by creating access to training opportunities, awareness, economic resources and income generation activities and ownership for women and girls.**

RDT has supported 26,449 women to start income generation activities to boost their financial independence, with special emphasis on single mothers.

In order to increase their social status, RDT has built 2,341 houses under women's names and 5,277 women were granted land property titles (pattas) with the support and assessment of RDT. 3,181 adolescent girls and 3,010 boys participated in gender workshops.

# COURAGE AND DETERMINATION TO BEAT THE STIGMA

#TRANSFORMINGLIVES

*“When my husband died seven years ago, I thought my life was over too, or at least that’s what everyone made me believe”, shares Padmavati. Mother of two and widow since she was 24.*

*“Raising happy and healthy children was the only thing that kept me going for a few years”, she remembers, “until RDT showed me that there was more for me”.*

Under RDT single mother’s programme, women like Padmavati get food grains and access to regular health check-ups, group counselling sessions and financial support.

*“In the group sessions, I share my problems and fears with other women in the same situation. I also got economic support to buy a buffalo. With what I earn, my family and I have a decent living without relying on others”.*

# OUR APPROACH

To address the health accessibility gap between the urban and rural areas, RDT started its first rural clinic in the late seventies and later expanded the hospital network, which now includes multiple specialities and is aligned with numerous Government health schemes, including YSR Aarogyasri. RDT works to improve access to healthcare and build awareness of various diseases and health problems to debunk myths that affect people's well-being.

# LINES OF WORK

**To enhance access to affordable healthcare through the RDT hospital network and rural and mobile clinics to reach rural and remote communities.**

RDT runs two secondary-level hospitals and two primary-level hospitals one of them in Nallamala Forest, with special emphasis on tribal communities. During the initial days of the deadly

second wave of COVID-19, RDT Bathalapalli Hospital was appointed as a COVID-19 healthcare facility and provided treatment to 2,607 COVID-19 patients in one and a half months.

Kalyandurg and Kanekal Hospitals remained open for general patients. Through our four rural and two mobile clinics, our medical staff at the grassroots spread awareness about COVID-19 symptoms, prevention and vaccination as per Government guidelines.

**To create access to rehabilitation services and promote autonomy in persons with disabilities to be able to lead independent lives and improve their quality of life.**

709 corrective surgeries were conducted and, 1,677 children up to 2 years were actively involved in the Early Intervention program, with the support of the RDT Hospital network and field staff who

identified them at the village and hospital levels. With the aim of increasing independence, our orthopaedic workshops team launched a mobile ortho workshop to reach remote places as deep forest hamlets in Nallamala forest. It also fabricated and repaired 5,648 aids and appliances for PWDs during 2021-2022

**To fight the burden of HIV and TB in partnership with the Government through awareness, access to treatment, follow up and counselling for the patients and their families.**

RDT Hospital for Infectious Diseases (HID), also known as Care and Support Centre, was appointed in September 2021 to provide a shorter all-oral novel treatment for multi-drug-resistant tuberculosis (MDR-TB) without injections. In May 2021, RDT Mycobacteriology Laboratory in Bathalapalli HID was also certified to perform TB Phenotypic Drug Susceptibility Testing by liquid

culture, which allows better identification of TB strains resistance. 1,663 TB patients and 7,768 HIV patients are currently registered for ART first line and second line in this facility, with an adherence of 94,5% to the treatment and a 0% rate of vertical transmission mother-to-baby.

**To ensure access to clean and safe drinking water and proper sanitation systems to promote hygiene, health and overall well-being of individuals and communities.**

Adequate access to clean water is essential for preventing and containing diseases. RDT constructs and facilitates access to pipelines and storage tanks. During 2021-2022, RDT installed 15 Reverse Osmosis Plants to provide potable water in villages, and built 2,472 bathrooms cum toilets. 3,467 persons attended awareness sessions on sanitation.

# 10 YEARS OF HELPING CHILDREN BE FREE OF HIV

23-year-old Nikhi\*, a seven-month pregnant woman, is one of the hundreds of HIV-positive mothers going to RDT Hospital to receive her ART treatment, follow-ups and counselling. *"We accompany the family in all the stages of their lives,"* explains Rhada, Social Worker in the centre. *"Being able to show pregnant women that if they take the medication, their children can be born HIV-free and they can still have a normal life changes everything",* she adds.

Children account for 7% of all the new HIV infections in India\*\*. In 2006 and 2007, when RDT Hospital for Infectious Diseases (HID) one child with HIV was diagnosed almost daily. In the last year, the average number of HIV-infected children diagnosed yearly has been below 20.

This is the result of a pioneering programme for the prevention of mother-to-child transmission (PMTCT) of HIV set up by the RDT medical team 10 years ago and which is aligned with the NACO National Strategic Plan on HIV/AIDS and STI, 2017-24.

# SOCIAL AND ECONOMIC EMPOWERMENT

To equip rural communities with tools to improve their living conditions through capacity building, income generation activities and access to property to lead a dignified life.



# OUR APPROACH

The lack of resources to cover one's own basic needs and a dignified shelter affects all aspects of life. RDT works with the communities and Government authorities to spread awareness and mobilise public resources, strengthen essential infrastructural services and facilitate access to individual and collective asset ownership and income generation activities. With special emphasis on women, persons with disabilities and tribal communities.

# LINES OF WORK

**To contribute to the empowerment of rural communities, specially women and persons with disabilities, through community-based organisations and by building their capacities and enhancing leadership skills.**

In 2020-2021, 24,831 PWDs and parents of children with disabilities were actively involved in 1,961 Vikalangula Sanghams. Out of these, 1,773 persons are part of mandal samakhya to represent the groups' issues at the district level. In the same period, 4,878 women leaders participated in leadership, public speaking and government resources mobilization training.

**To facilitate access to livelihoods and economic independence to pave the way to self-confidence.**

In the reported year, 26,449 women sangham members got the necessary support to start income generation activities in order to increase their social status within the community and secure their future. Also, 4,964 PWDs have been supported to set up income-generation activities and thousands of PWD and their families have been assessed to mobilise Government resources, like job cards, medical certificates, scholarships, Government land sites and transport cards among others.

**To strengthen access to dignified shelter and community-owned assets for the holistic development of societies.**

RDT partners with communities to increase their asset base by providing them with the infrastructure they lack and supporting the Government to improve the existing ones. For that purpose, 8 government educational institutions and 2 Anganwadis have been assisted and 13 community centres cum Supplementary Schools built as collective owned assets.

# FROM LIVING WITH THE DEAD TO LIVING WITH DIGNITY

#TRANSFORMINGLIVES

Nagamma cannot speak without coughing. This is only one of the many side effects of having lived for more than 40 years in a small shed between graves. *“Every person in this place is sick in some way or the other,”* she explains, referring to the 251 residents of Bogadi Thotu Cemetery, a slum near the Nellore city landfill.

However, in March 2021, after overcoming many obstacles and with the support of the local government, Nagamma and 251 other families moved to dignified houses built by RDT in the same city.

The design of the house was adjusted to the particular weather in the region and the local communities were actively involved in the process, with the women being the ones leading it.

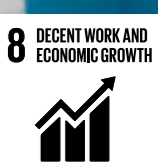

# CHILD PROTECTION AND EDUCATION

To ensure that every child and adolescent fulfil their potential by growing up in a safe and inclusive environment and have equal access to opportunities while addressing educational inequalities.



# OUR APPROACH

The global challenge for education is not just about providing access but also about ensuring quality and equal opportunities from primary to higher and technical education through direct initiatives and by supporting Government schemes. We implement holistic and inclusive curriculums to ensure that children with and without disabilities grow up in safe environments in order to fulfil their potential.

# LINES OF WORK

**To implement inclusive education and holistic curricula for children from vulnerable communities to enable them to develop their skills and capacities.**

1,208 children with and without disabilities are enrolled in the RDT dual model of education for children with disabilities. While children with

moderate and severe intellectual disabilities and cerebral paralysis (472 children) are provided with special schools that serve a rehabilitation and autonomy-readiness goal, children with visual, hearing, speech and motor disabilities study together with children without disabilities (mainly orphans) in inclusive schools (736 children), with an approximate ratio of 7:3 (CWD: children without disabilities).

**To secure future opportunities for children and youth through training, counselling and foreign languages to develop their employability skills.**

RDT General Support Programme and Special Scholarships programme has assisted over 5,915 students from vulnerable families studying graduation and post-graduation in some of the best institutions of the country.

The Professional School of Foreign Languages, which shifted to an online format due to the pandemic, achieved an 85% employment rate for its students and opened a new course for over 125 students from vulnerable communities. Additionally, 182 youngsters with disabilities were provided with assistance and training to access higher education and technical courses.

**To build capacities that contribute to individual and community development by ensuring access to the necessary tools and supporting the efforts of the Government.**

To palliate the effect of poor infrastructures still prevalent in rural areas, RDT distributed 3,319 bicycles for High School students and provided laboratory and sports kits to 45 Government Centres. The sports leagues at the grassroots

restarted and involved 6,642 children (42% girls) and their parents.

**To protect the most vulnerable children and ensure that they grow up in a safe environment away from discrimination, stigma and abuse.**

Through its two children homes, 49 children living with HIV or affected by HIV were provided with accommodation, proper nutrition, counselling and health check-ups. During 2021-2022, 1,045 orphaned children received financial support to access education in boarding schools covering the cost of accommodation and food and providing them with counselling and emotional support.

# PAVING THE PATH TO A BRIGHT FUTURE

#TRANSFORMINGLIVES

Born in Medimalakalapenta, a deep forest village in Nallamala Forest, Nagalakshmi lost her parents at a very young age. Poverty and a lack of hospitals in the vicinity motivated her to become a doctor, against all odds.

The lockdowns due to COVID-19 posed a threat to her dreams, as her brothers wanted her to get married.

With determination, Nagalakshmi continued her education while attending online classes on top of the mountains in the deep forest.

*"Giving up is easy, but I wanted to pursue my dream of becoming a doctor. RDT is helping to make it a reality. I am currently taking coaching classes to become a doctor in the future,"* says Nagalakshmi.

# LINES OF WORK

**To protect the environment to ensure tomorrow's livelihoods through afforestation and water conservation activities.**

Afforestation and conservation offer watershed protection, prevent soil erosion and mitigate climate change. 3,61,200 plants have been dibbled this year for afforestation purposes. In Anantapur district, a drought-prone area, water conservation has always been a pillar of RDT's work with rural

communities. During 2021-2022, 14 check dams were built, and with RDT's support, 1,486 farmers from Rayalaseema region shifted to sprinklers, drip and micro irrigation systems.

**To foster environment-conscious communities to promote a lifestyle in harmony with nature.**

Under the initiative Mana Bhoomi ["Our Earth is our Home" in english], more than 700 RDT staff

members and their families attended awareness sessions about sustainability and more than 200 children are actively engaged in the celebration of Earth Saturday activities. Through this same initiative, one composting unit was installed, and solid waste management systems are being set up on 8 RDT campuses. A dry toilet pilot project has also been implemented to improve the sanitation systems in regions with water scarcity.

# DROPS OF LIFE, JOY AND FULFILLMENT

#TRANSFORMINGLIVES

Basappa used to cultivate groundnut in the 3 acres that he owns. However, the scarce and erratic rains dried up the bore wells, forcing him to ask for a loan to be able to feed his family. The rains he expected never came.

*"I was desperate. I packed my things and migrated to Bangalore. For eight years, I worked in different odd jobs to earn enough to repay the loan and send money to my family back in the village", he explains.*

Basappa was only one among the many farmers in distress. Hence, the community approached RDT. After the necessary identification, RDT sanctioned the construction of 3 water check dams in the village and drip irrigation installation for the most vulnerable farmers. Basappa was among them.

*"Today, I can live in my village with my family, pay for my daughter's education and take care of the land. The tomato and chillies crops have been successful this year," he adds.*

# RUN FOR CHANGE: AUM 2022

The VII Anantapur Ultramarathon (AUM), known as the only relay ultramarathon in India, took place on 22nd January 2022 in RDT's Anantapur Sports Village and involved 1,000 runners worldwide.

Under the slogan, "1KM, 1 life", the event became a unique experience for those passionate about running and social transformation.

Due to the rise in COVID-19 cases, and the travel restrictions, the participants gathered in Anantapur were limited.

**A total of 54 runners, out of which 10 were persons with disabilities, joined in person from Anantapur. At the same time, runners from 7 different countries -Spain, Germany, the**

**USA, Ireland, Italy, Turkey and Australia- joined simultaneously from their locations, making this seventh edition the most international one.**

The funds raised in this edition supported the organisation's work against COVID-19 and the implementation of the holistic development project that RDT takes forward in over 3,819 villages across AP and Telangana.

# INDIA FOR INDIA: CHAMPIONS OF EDUCATION

Due to the COVID-19 pandemic, India for India movement, an initiative started in 2012 by people from the villages under the slogan, "Spandinchu Sayam Andinchu" ("Let your hearts respond and hands help") could not be celebrated as expected on the 9th April.

To respond to the need of the hour, RDT staff launched, on 14th November, CHAMPIONS OF EDUCATION, a campaign to raise funds to support the education and development of those children and their families worst affected by the pandemic in Andhra Pradesh and Telangana.

More than 119 individual donors and companies supported the dreams of those children that the pandemic had put on hold. The team mobilised Rs. 34 lakh to ensure access to education, accommodation, food, provide emotional counselling, and health check-ups for 60 children.






